### RoHS and its Impact on J.S.T. (U.K.) Ltd

J.S.T. (U.K.) Ltd fully supports the EU directive ([2011/65/EU](#) (the RoHS Directive) and its subsequent amendments on the Restriction of the use of certain Hazardous Substances in Electrical and Electronic Equipment (EEE).

J.S.T. (U.K.) Ltd is also aware of the EU Commission Delegated Directive [2015/863/EU](#) of 31<sup>st</sup> March 2015, amending Annex II to Directive 2011/65/EU of the European Parliament and of the Council as regards the list of restricted substances. This directive requires that the UK (member state) adopt and transpose the provisions into national law by 31<sup>st</sup> December 2016.

This legislation bans the placing on the EU market of new EEE containing more than the agreed levels of:
